IFRC General Assembly (GA) 23-25 October 2024

- Supreme governing body of the International Federation
- Determines vision and strategy of the International Federation, and the general policies that govern, the International Federation and the National Societies

The Council of Delegates (CoD) 27-28 October 2024

- Brings together all the components of the Movement
- Sets common Movement strategies and approaches and debates global humanitarian issues

The International Conference (IC) 28-31 October 2024

- Supreme deliberative body of the Movement
- Brings together components of the Movement, states party to the Geneva Conventions, and observers
- A unique non-political forum in which the Movement components have the same voice as States


